

LEGAL TERMS

I IDENTIFICATION AND ACCESS

This website www.galeriedior.com (the «Website») is published by Christian Dior Couture, a French limited liability company (société anonyme) with a board of directors and a share capital of 291,125,408 Euros, registered with the Paris Trade and Companies Registry under number 612 035 832, whose registered office is located at 30, avenue Montaigne, 75008 Paris - Telephone number: 01 40 73 73 73; e-mail address: contactdioreu@dior.com; VAT number: FR 37 612035832.

The Chairman of the Board of Directors of Christian Dior Couture and Director of the publication is Mr. Pietro BECCARI.

The Website is hosted by the company Digital Ocean, whose registered office is located at 101 Avenue of the Americas, New York 10013, telephone number: +1 347-903-7918.

Access to the Website as well as the use of its content are carried out within the framework of the terms of use described below. By accessing and browsing the Website, the Internet user accepts without reservation the following terms.

II. INTELLECTUAL PROPERTY

2.1 Ownership

Christian Dior Couture owns the domain name of the Website.

The Website as a whole, as well as the elements that it contains (in particular, texts, tree structures, software, animations, photographs, videos, illustrations, diagrams, graphic representations, logos, etc.) constitute intellectual works protected by articles L. 111-1 et seq. of the French Intellectual Property Code. They are the exclusive property of Christian Dior Couture, which alone is entitled to use said intellectual property rights as well as the related personality rights, trademarks, models, intellectual works, software, databases, interpretations, and images of persons, either as original property or by virtue of a license or an express authorization.

2.2 Sanctions

The use of all or part of the Website, in particular by downloading, reproduction, transmission, representation or broadcasting for purposes other than for the personal and private use of the Internet user for non-commercial purposes is strictly prohibited. Violation of Christian Dior Couture's rights exposes its author to the penalties provided for both by the Intellectual Property Code, in particular for copyright infringement (Article L. 335-1 et seq.) and trademark infringement (Article L. 716-1 et seq.), and by the Civil Code in terms of civil liability (Article 9, Articles 1382 et seq.).

2.3 Hypertext links

The creation of any hypertext links to any of the web pages or elements making up the Website is prohibited, except with the prior written authorization of Christian Dior Couture, which authorization may be revoked at any time. V. DISPUTES

The French courts are territorially competent to hear any dispute relating to the use of the Website, except for provisions to the contrary arising from Regulation No. 44/2001 of 20 December 2000 on jurisdiction and the recognition and enforcement of judgments in civil and commercial matters (Brussels I).
